ABOUT SUNRAIL

SunRail is a commuter rail line that consists of 61 miles of service from DeLand, through Orlando and downtown Kissimmee to Poinciana. Phase 1 is 32-miles and will connect DeBary in Volusia County to Sand Lake Road in Orange County. SunRail trains will operate on weekdays, every half hour during peak periods from 5:30 a.m. to 8:30 a.m. in the morning and from 3:30 p.m. to 6:30 p.m. in the evening; and at two hour frequencies during non-peak hours.
